

## Terms and Conditions

---

Your use of the service named “meal for bridge” and offered by GOB Corporation (the “Services” ) is governed by these terms and conditions set out in this document ( “T&Cs” ). Unless GOB Corporation (the “Company”) expressly agrees to the contrary in writing, all your dealings with the Company will be on and subject to the terms of these T&Cs. By using the Services, users, including both Guests and Hosts (the “Users”) agree to be bound by these T&Cs.

### 1. Basic Terms

The Service shall be applied for by the traveler as a guest (hereinafter “Guests” ) and the Japanese host (hereinafter “Hosts” ), both of whom are family members accompanied by their children. Guests and Hosts under 20 must be accompanied by a supervising adult in each family over 20 years of age to use the Services. By using the Services, you represent and warrant that the supervising adult in your family is aged 20 years or older and any representation that you publish is true.

### 2. Meals

Please be aware that the Hosts nor the Company will take any responsibility for incidences of food poisoning or any other illness.

The Company and the Hosts cannot guarantee the absence of specific allergens in the menus or promise to fully accommodate various dietary restrictions.

#### 2-1. Charge

As of January 23, 2025, the date the T&Cs were enacted, no fee will be charged to Guests or Hosts for use of the Services, as the Services are intended as a sample for Users to try before the official version is released to the public. The Company will also pay for any meal expenses incurred while using the Services. Transportation costs are not included in the Company's contribution.

However, please note that this will not be the case after the release of the official version, and fees are

### 3. Late arrivals and Cancellations

Both of the Guests and the Hosts shall be considerate and avoid cancellations and arrive on time. If you have to cancel the Services, please contact the Company and your matched family as soon as possible.

The Company will allow you to change meeting time and point but once you choose to make these changes, it is the responsibility of the Users to arrive at the correct location at the scheduled time.

If your matched Guests or Hosts do not show up on the day of the event, the meal will be cancelled. In case there is a cancellation fee to the restaurant, the Company will pay it. Guests or Hosts arriving on site as scheduled may dine at the restaurant, but notwithstanding Article 2.1, they will be responsible for their own food and beverage expenses.

## 4. Limitation of Liability

The Company assumes no responsibility for the actions of Hosts, Guests, and other Users through any Services or Meal for Bridge website. Guests, Hosts, individuals and families alike, must agree that you are at your own risk when using the Services. The Company makes no representations or warranties with respect to the conduct of the Users. The Users shall further acknowledge that the Company shall not be liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with the use of or reliance on any content, events, goods, or services available.

## 5. Prohibited practices

The Users shall not give, commercial dealing, spam or solicitations or do any illegal activities before, during, or after the Services.

The Users shall not do any discrimination or harassment during, or after the Services.

The Users shall not engage in any act that directly or indirectly provides benefits to antisocial forces in relation to our services.

The Users are prohibited from using the Service for the purpose of dating or sexual encounters.

The Users shall not post any content that is harmful or invasive of another's rights, interests, or privacy including Hosts, Guests, or the Company, including but not limited to distributing another person's personal information or images of any kind without their express permission.

The Users shall not damage, disable or disrupt the Services by any means.

The Company has the right to edit, remove, or delete any posting that violates these T&Cs or is otherwise objectionable.

## 6. Terms and conditions are subject to change

The Company reserves the right to modify the T&Cs without requiring the individual consent of the User in the following cases;

-When the modification of the T&Cs is in the general interest of the User, or

-When the modification of the T&Cs is not contrary to the purpose of the Services and is reasonable in light of the necessity of the modification, the reasonableness of the modified contents, and other circumstances pertaining to the modification.

The Company will notify the Users through the website, in advance of any changes to T&Cs as described above, as well as the contents of the revised T&Cs and when the changes will take effect.

## 7. Business Transfer to a Third Party

In the event that the Company transfers the business related to the Service to a third party (regardless of the form of the transfer, such as business transfer, company split, etc.), the Company may transfer the status of the user contract, rights and obligations under These T&Cs, user registration information, and other customer information to the transferee of the transfer and the User shall agree to such transfer in advance in this paragraph.

## 8. Compensation for Damages

In the event that the User intentionally or negligently infringes upon the rights or legally protected interests of another, including the Company and another User, the User shall be liable for compensation for damages resulting from such infringement.

## 9. Exclusion of Anti-Social Forces

1. "Anti-Social Forces" means:

(1) an organized crime group, a member of an organized crime group, a related company or association of an organized crime group, and any other equivalent person of above; or

(2) a person who themselves or through the use of third parties conducts a demand with violence, an unreasonable demand beyond its legal entitlement, use of intimidating words or actions, damages the credit or obstructs the business of the other party by spreading false rumors or by the use of fraudulent, or any other equivalent actions of above.

2. The User represents and warrants that is not a person who has fallen and shall not fall under any of the followings:

(1) the Anti-Social Forces;

(2) a person having such relationship with the Anti-Social Forces that shows the Anti-Social Forces' substantial involvement in the person's management;

(3) a person having such relationship with the Anti-Social Forces that shows reliance on the Anti-Social Forces;

(4) a person who cooperates and is involved with the maintenance or operation of any Anti-social Forces by providing funding to any Anti-Social Forces or any similar act; or

(5) a person who is engaged in a socially condemnable relationship with the Anti-Social Forces.

3. If the User breached the representations and warranties in the preceding clause, the Company shall be entitled to terminate the use of the Service by said User and request for the damages without any notice and any and all obligations of the User owed to the Company shall become due and payable and the User shall immediately repay such obligations. The Company shall not be obligated to compensate or indemnify the User who has violated this Article for any damage caused thereby.

## 10. Miscellaneous

These T&Cs shall be governed by and construed in accordance with Japanese law and the Company and you each agree to submit any dispute, including disputes relating to any non-contractual obligations, which may arise out of, under, or in connection with this agreement to the exclusive jurisdiction of the Japanese courts and The Osaka District Court shall be the court of exclusive jurisdiction of the first instance.

These T&Cs are made in Japanese and translated into English. The Japanese text is the original and the English text is for reference purposes. If there is any conflict or inconsistency between these two texts, the Japanese text shall prevail.
